#### LEGISLATION / OPERATION MORNING STAR Chair/Submitted by: Karen C

The following information is a summary of an article which appeared in the Operation Morning Star Newsletter for December 2010. The title of the article is "Obamacare expands abortion coverage three ways". The information is from Stephen Mosher, president of the Population Research Institute.

There are three ways that the Patient Protection and Affordable Care Act funds abortion. Money for so-called Community Health Centers: Many of these centers will be run by Planned Parenthood and, without abortion-restricting language in the bill, money that goes to these centers will be used for abortions.

Money for federal insurance plans: Obamacare will provide two or more state-sponsored insurance plans. According to the bill, only one of the plans needs to have restrictions on abortion. Federal dollars will almost definitely be paying for abortion in the other state plan.

Money for "temporary high-risk pools": This money goes straight to the states. Some states tried to use this money to fund abortions until complaints by National Right to Life forced Health and Human Services to promise it would actually enforce Obama's executive order.
