The Most Rev. Mark L. Bartchak was ordained and installed as the eighth Bishop of the Diocese of Altoona-Johnstown on April 19, at the Cathedral of the Blessed Sacrament in Altoona. Cardinal Justin Rigali consecrated the new Bishop, along with the Most Rev. Joseph V. Adamec, Bishop-Emeritus of Altoona-Johnstown, and the Most Rev. Donald Trautman, Bishop of the Diocese of Erie. Archbishop Pietro Sambi, Apostolic Nuncio to the United States of America, was in attendance and read the Papal Decree. Almost two dozen other Bishops were present, along with more than 1,100 invited guests. Bishop Bartchak's Episcopal motto is "Christ our Hope of Glory."
