Holy Cross Family Ministries - National Charity

Many of you know that the Holy Cross Family Ministries (Fr. Patrick Peyton Center) has been a National Charity since 1977. Back in 1948, Fr. Peyton sought the support for his Crusade for Family Prayer. CDA answered the call to promote Family Rosary in homes and parishes.

In 1952, Fr. Peyton again turned to the Catholic Daughters to help finance the cost of \$25,000 for his new venture in radio.

Holy Cross Family Ministries broke ground on November 2023 to expand the center and to have a dignified resting place for Venerable Patrick Peyton, a beautiful Lourdes Grotto and a Rosary Garden.

The National Board has made a pledge of \$100,000 over a four years, for the Marian Statue in the Lourdes Grotto, to the "We Prayed a Campaign for Family Prayer," which marks 75 years since our initial support. Because of your generous donations, we have already sent our first \$25,000.

Please continue to support this ministry with donations from your state, local, territorial courts, individual members and families. If you are not able to donate, please pray for this campaign that it is successful and for the Glory of God.

The group cooks the meals, packages and delivers them personally. Since its beginning, the ministry has delivered over 2,000 meals.

This is truly a wonderful ministry, and we at Court Bellevue are so happy to be able to help in a small way. We filled 150 treat bags to go with the Christmas meal. 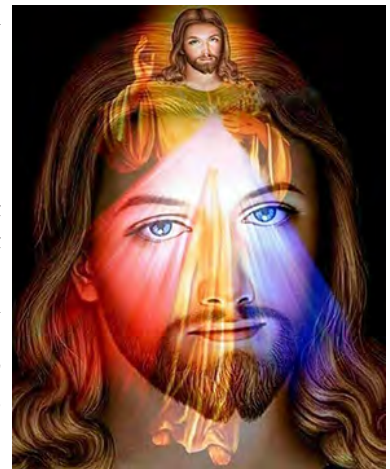

As I write this, the Season of Lent is just around the corner—beginning February 14th. I wish everyone a prayer-filled, contemplative time during Lent and the Triduum...as we prepare for our Risen Lord on Easter Sunday, March 31st.

Our state has its own donation form, which includes space for local court donations to our Pennsylvania State Court pro-life projects, followed by donations to our national projects and national charities. Pennsylvania local courts should use this form and send it, along with one court check, for all three groups of donations, to our Pennsylvania state secretary. The form can be located here: <https://cdapa.com/forms/donation-form.pdf>. You will know you are using the correct Pennsylvania State Court donation form by looking in the bottom right corner where it says "Revised: August 12, 2023 at 11:28 AM."

Our national website has the forms we need to keep our court records in order. Many you can find by visiting <https://catholicdaughters.org/> and at the very top, select forms. Forms of particular importance for court membership records are: Request Court Roster, Application for Membership, Local Court Officers/New Officer List, Information Correction Form, Dual Membership, Transfers, Renewal, and Membership Deletion Report.

Financial Review forms are also available, in the forms section, on national's website. Depending on the review cycle, these are due to the national office and the state (secretary-and-regent) by April 30th and October 31st. You can mail them via USPS or by email. As explained in our Bylaws (Article IV Dues Section 2 National and State Dues—page 5), membership dues are based on the number of members recorded at the national office as of March 31st and September 30th and is billed on or about May 15 and November 15 and is payable within thirty (30) days. A good practice to follow is written in our Tools of the Trade (aka Procedures Manual) which is to "Periodically request a membership roster from the National Office to compare with court records for accuracy and address any discrepancies."

Ideally, courts will request a copy of their local court roster in mid-February and again in mid-August, in order to have time to update the national office and state court with their local court membership records, prior to the six-month billing date. This is optimal in that if a member joins or drops during the year, local courts are not paying for them once in a 12-month period, but rather a 6-month period—thereby giving time for membership adjustments to be reflected in the biannual bill.

Requesting a roster is easy and can be obtained by national board members, state officers, district deputies, regents, and financial secretaries by visiting: <https://catholicdaughters.org/request-court-roster> or by sending an email to cdaroster@aol.com or to [\[catholicdaughters.org\]\(https://catholicdaughters.org\). When reviewing your roster be sure to note that all of your officers and court chaplain/spiritual advisor are listed as holding their specific office; that dual/secondary members are shown as such \(in the second local court they join, not in their original court, where they are just listed as a member\); and that all of their contact information is current and formatted correctly. Then, once your review is complete, use the appropriate form to add, delete, correct...the information, sending it to the national office-and-to our state regent, state secretary, your court's district deputy, keeping a copy for your own records.](mailto:gertrude@</p></div><div data-bbox=)

Are you in need of your own copy of our bylaws? Copies of our bylaws, along with quite a bit more, can be purchased from our Catholic Daughters store! You can even pay for your order using PayPal! Visit **national's website** at <https://catholicdaughters.org> and select "Store" from the main menu. Keep in mind, our bylaws change every two years, during every national convention; as such, a new bylaws book will be published after our 60th Annual National Convention, August 14-18, 2024, New Orleans, Louisiana. These books are typically available a month or two after the national convention.

Transition 2024- 26 Local Court Officers What's in the Works??

At the May meeting, each local CDA court will have election of officers for 2024-26. When the election takes place at a court meeting by plurality vote or by motion, if there is only one nominee for an office, each officer shall assume the office to which she has been elected, with or without installation, thirty (30) days after her election (Bylaws: Article XIII, Section D—Elections, page 40).

What's Next??

Set meeting date for the NEW 2024-2026 corp of officers WITH the outgoing officers. Each outgoing officer brings all data pertaining to her office (Courts, Section 7—Duties of Local Court Officers, pages 35-39):

- Responsibilities, instructions, minute books, ledgers, reports
- Bank books and statements, forms, info from National
- State courts and Diocesan Committee, Bylaws book, which outlines duties of each office (Article XII, Local)

Each outgoing officer explains duties she performs:

- Displays books, documents, etc. Each new officer now knows the responsibilities of her sister officers.
- Develop tentative list of committee chairs, with at least two other members on each committee.
- Call each for her commitment to serve.
- Review upcoming events, develop tentative yearly calendar, consider new project/program to present as an Officers' Recommendation at next court meeting.
- Be "on call" to help a sister officer! Always here to help.

The CDA national office provides to each member the opportunity to utilize the TOOLS OF THE TRADE manual which is made available on its website. Encouragement must be made to CDA members to review the TOOLS OF THE TRADE and be familiar with the Local Court segment of the manual. Courts should make opportunities available to members like a mini-workshop for members to learn what the duties of each office entails and how the court interacts with the State court. Now is the time for such activities, as the terms for current officers are expiring.

Engage CDA members in court activities and use the member's skills to the advantage of the court activity. Leaders delegate and listen to the members who are assigned with their parameters to manage. Leadership styles differ, and if all members are respectful of each other, then the objective of the activity will be accomplished without conflict.

Your assignment is to observe and encourage your court members to volunteer in ways that will enrich their experience within the court and potentially have the member say YES to a leadership position at any level.

Put on the Whole Armor of God

Dear Friends in Jesus Christ,

Lent is a season when we face the reality that our baptismal identity is always being put to the test, when we remind ourselves of the struggle we are always engaged in to be faithful to the call of our baptism.

If remaining faithful to His baptism was a struggle for Jesus, it will certainly be a struggle for us. You could say that Lent is a season when we look temptation in the eye as it were, when we try to identify the particular ways in which we are being pulled away from the path the Lord is asking us to take. It is a season when we try to grow in our freedom to say 'no' to the subtle, and not-so-subtle, seductions of everyday living. It is a time when we take an honest look at ourselves, and at the direction our lives are taking.



This is not something we can do overnight. The season of Lent is nearly seven weeks long. We are given time, because when it comes to getting the basics right, like who we want to be and how we want to live, we need time.

In the wilderness, Jesus faced an assault on what was deepest and best within Him, but He did not face that assault alone. He had resources to combat the spiritual assault. According to the Gospel (Lk 4:1-13), Jesus entered the wilderness "filled with the Holy Spirit." When he was at His most vulnerable, the Spirit was at work in His life. He also had the resource of the Scrip-

tures, the word of God. He lived off every word that came from the mouth of God, and that word helped to keep Him faithful when He was put to the test.

We have the same resources at our disposal in our own testing times. The word of God is given to us to keep us spiritually alive, and the Holy Spirit is always at work deep within us, directing us towards what the Lord wants for us. We also have the resource of the community of believers. We are hearing a lot about armaments at the moment, but all of this is our spiritual weaponry.

In one of his letters Saint Paul exhorts us, "Be strong in the Lord...put on the whole armor of God, so that you may be able to stand against...the spiritual forces of evil."
