- ♥ Regent will always ask the member to put the idea "in the form of a motion" (I move to or that...)

### How a Motion Made ~ Eight Essential Steps?

#### The Member:

- ♥ 1) Rises and addresses the Chair, "Worthy Regent"
- ♥ 2) Receives recognition from the Regent, "Yes, Mary (their name)"
- ♥ 3) Introduces/States the motion, "Worthy Regent, I move to (or that) ..."  
(Add what you want to do or have done; no other format/wording should be used.)
- ♥ 4) Another member "Seconds" the motion.

#### Then, the Chair/Regent:

- ♥ 5) States the motion.
- ♥ 6) Asks for discussion, both pros and cons.
- ♥ 7) Takes the vote: Regent says, "All those in favor say Aye" and then, "All those opposed, say "No."
- ♥ 8) Announces the result of the vote: Either "the Ayes have it and the motion carries"; or, "The Nos have it, and the motion is lost." A counted vote may be necessary at times. A vote that is tied, is lost.

# *Introducing CDA Court #2625*

## *Gift Card Rebate Program* *An Easy and Profitable Fundraiser!*

May 2, 2010, after a few planning and preparation months, our Court placed its first Gift Card Rebate Program order!

At the close of our first quarter, April - June 2010, an overall profit of \$1,027.36 has been raised!

Four orders, a total of 20 unique patrons, \$1,027.36 in profit!

It can't get any easier ... although, with your help ... the profits can grow, and grow, and grow!

Please, purchase gift cards at our monthly meetings and/or place your orders regularly.

### *How our Gift Card Rebate Program Works ...*

- ♥ Three members of our Court invested a total of \$3,010.00 to our Gift Card Rebate Program. Thank you! These loans made it possible for our Gift Card Rebate Program to purchase gift cards at a discounted rate from local retailers such as Martin's Food/Pharmacy, Weis Markets, King's, and The Dream; all of whom have minimum ordering requirements and to have additional retailers: Giant Eagle, Walmart, Lands' End, Hoss's, and Sheetz available for Direct Sale purchase.
- ♥ At our monthly meeting, you can purchase gift cards for the items we stock: Giant Eagle (\$25 or \$100), Martin's Food/Pharmacy (\$25 or \$100), Weis Markets (\$25 or \$100), Sheetz (\$25), King's (\$10), Hoss's/Marzoni's (\$10 or \$25), The Dream (\$10), Lands' End (redeemable at Sears, Kmart, and land-send.com \$25), and Walmart (\$25).
- ♥ You can also submit a paid Order Form order, for items we do not stock, twice a month.
- ♥ Twice a month we combine the individual Order Form orders and Direct Sale purchases from our monthly meeting, into one primary order; our schedule is on the front of the Order Form.
- ♥ After our deposit is made, our vendors are called with the number of gift cards we are ordering from them; we verify the net due (cost less the rebate) and the day we will be there to pick them up.
- ♥ A few days later, we visit our local vendors to pick up and pay for our order. As an example, if five people ordered a combined total of eight \$25.00 Jethro's gift cards, with a 15% rebate, when we picked up the eight gift cards at Jethro's, we would give them a check for \$170.00 (\$200.00 cost less \$30.00 rebate.) The profit is realized immediately! When you use the gift card, it is for the full face-value, in this case \$25.00. We also purchase gift cards from our primary vendor, Great Lakes Scrip Center, who electronically transfers the net due (the cost plus shipping minus the rebate) from our checking account after we call in our order and then ships our gift cards to us.
- ♥ During the ordering week, once all the orders are received, we fill the individual orders for pick up at our monthly meeting or if the order is placed at or after the meeting, you can pick it up at Saint Rose of Lima's Rectory. All the pick up dates, times, and locations are shown on the Order Form. Our group of eight dedicated volunteers are also willing and able to assist anyone in making other drop off or pick up arrangements. Their names and phone numbers are on the next page of this newsletter
- ♥ According to the quarterly schedule on the Participation Agreement and how you chose to apply your rebates, disbursements of the rebates earned are made.



## *The Order Form has been Updated.*

The updated Order Form is dated July 30, 2010. Please, discard any Order Forms with a different date.

Added to the Order Form: Six Flags Theme Park \$30.00 with an 8% rebate

Rebate Change: Chili's rebate is now 9%.

Removed from the Order Form: 675 Minute Phone Card; BP Gas; and Kmart and Sears (order Lands' End instead!)

Many patrons regularly use Lands' End Gift Cards at Kmart and Sears to purchase appliances, bedding, clothing, shoes, cosmetics, tools, electronics, games, toys, prescriptions, toiletries ... Kmart also sells gift cards such as: TGI Friday's, Outback, Olive Garden, Red Lobster, Chili's, Applebee's, Cracker Barrel, iTunes, Barnes and Noble, Phone Cards, the Marriott ... and many more ... all with the great rebate of 16%! That's a \$16.00 rebate for every \$100.00 purchase! However, you cannot purchase Visa/MC/American Express gift cards at Kmart with a gift card.

## Barbequed Pork Ribs

### Ingredients:

- 1 14 ounce bottle of Ketchup
- 1 14 ounce bottle of Water
- 1 Tablespoon Vinegar
- 1 Tablespoon Worcester Sauce
- 3 Tablespoons Brown Sugar
- 3 Pounds Pork Ribs

### Method:

- ♥ Mix all ingredients, except the Pork Ribs, together thoroughly.
- ♥ Brown ribs in frying pan.
- ♥ Bake uncovered in a 350° oven for about one hour.
- ♥ Drain any excess grease.
- ♥ Pour on the prepared Barbeque Sauce.
- ♥ Basting often, bake uncovered for an additional hour or until the meat pulls from the bones.
