

#### **MEMBERSHIP**

It's time once again to talk membership. With spring approaching and warmer weather due to arrive, plan on enjoying some of the nicer weather by planning a membership drive. Listed below are ideas to help.

#### **Establish Goals**

Determine the number of new members you are to striving for. Provide incentives and perks for present members to bring in new members. Incentives may include gift certificates to restaurants or movie theatres or to an upcoming spiritual event in your community. Perks may be that the member can be the first in line for refreshments and not have to help clean up. Make your incentives and perks special so that everyone will want to participate.

#### **Advertise**

Make sure that whatever format your court chooses to recruit new members, the entire membership is aware of it. Posters, flyers, announcements, newspapers, radio, cable, bulletin boards, facebook, websites and personal contact should all be used to get the word out about an upcoming membership recruitment event.

Ideas include hosting an Easter Egg hunt for the children and inviting the moms to become members, hosting a brunch or luncheon for Mother's Day, and hosting a walk for one of the National or State Charities and Projects and invite the women who sign up to become members. Don't forget to ask the men who attend to encourage their wives, sisters and other women they know to consider joining the CDA. Be sure to have the pamphlets and flyers ready for them to take.

#### Be Organized

Planning an informational membership event, regardless of whether or not it is a social or formal event, needs to be thorough and done well in advance. Involve all your officers and as many members as possible. Establish a timetable. Arrange for the facilities, refreshments and all outside assistance. Call upon and use your District Deputies, Diocesan Chairs, and State Officers.

#### **Get Help from Outside Sources**

The court can contact a speaker from a local organization that the court supports such as the food bank or a member of a religious order to be available at a membership drive meeting.

#### **Arrange for Transportation**

This is probably the most overlooked aspect of membership. Assign a transportation committee to provide transportation for those who have difficulty making meetings and events.

#### **Invite Women to Join**

You may have a postcard campaign at one of your meetings whereby members invite someone via postcard. Personal invite is always a good way to get new members. After the informational aspects of your membership event are completed, present a membership application to each prospect. Avoid high-pressured salesmanship, but make sure you do ask all prospects to join the court. Follow up on all prospects and access from their responses how successful your events/meetings have been in recruitment.

#### **Assign Duties to New Members**

Women who join the court should be formally inducted at a meeting. They should be assigned specific duties within the court immediately. It is important for new members to feel useful and needed. Don't over do it, though, as you don't want your new members to experience burn-out.

#### **The CDA Structure**

All members, new and old, should know exactly how they fit into the CDA structure. All members are important—all should be involved in committees and projects that rely on their participation. The viability of your court depends on the involvement of the total membership, and it's best to start new members out right.

### Message from State Chaplain

Dear Catholic Daughters and Friends,

appy New Year! (I realize you are reading this column weeks after January 1st; however, this is the first opportunity I have to offer you blessings on this New Year. May the Lord continue to shower His blessings on you, your families and the good work you do!)

As you read this letter, we will soon (or already have) started our season of Lent. May each of us use these weeks of Lent to deepen and strengthen our love for the Lord and His Church.

Keeping with the spirit of Lent, I would like to offer three invitations to each of our Courts in the state of Pennsylvania.


The first is the invitation for each of our Courts to create an opportunity to attend Stations of the Cross as a Court (at least) once during this Lenten Season. Most parishes have Stations of the Cross scheduled during Lent. If your parish does not, I am sure one of your neighboring parishes does. (This occasion may also present the opportunity for others attending the Stations to ask 'who you are' and then give you the opportunity to share some of the good works the Catholic Daughters does in the Church.) While Friday evening is the customary time for parishes to pray the Stations of the Cross, present-day circumstances sometimes warrant that the Stations be prayed on other days and at different times. (If you search, you will be able to find a church where the Stations are prayed at a convenient time for most of the members of your Court.)

The second and third invitations occur on the same day and represent an issue very dear to the Catholic Daughters—the Priesthood.

I encourage all of our Catholic Daughters, whether it can be done as a Court activity, or on a personal basis, to attend the Chrism Mass during Holy Week in the Cathedral of your (arch)diocese. While Holy Thursday morning is the traditional day for the Chrism Mass to be celebrated by the bishop, many dioceses across the country celebrate

this Mass on a different day earlier in Holy Week. (If you ask your pastor or chaplain, he can tell you what day the Chrism Mass is scheduled for your diocese, as well as the time.)

The third invitation I would extend to you is to join in the celebration of the Mass of the Lord's Supper celebrated on Holy Thursday evening. I have always found the Holy Thursday evening



Liturgy to be one of the most beautiful, peace-filled liturgies of the entire year. Attending this Liturgy (whether as a Court or as individuals) is a wonderful expression of our faith in the Eucharist, as well as a great show of support for the priests who accompany you on your journey of faith.

These days of Lent will be over soon; don't let them pass by without using them to strengthen your faith! Make the best of Lent, so the Lord can make the best of you!

May the Lord continue to bless all our efforts offered in His name, and may His Mother, Mary Immaculate, Patroness of our nation, watch over us and intercede for us! Mary Immaculate, pray for us!

This year was the 6<sup>th</sup> March for Life I myself attended. The bus I ride leaves from St. Bernadette Church in Monroeville. Fr. Tony celebrates Mass for us at 5:30 a.m. and the bus pulls out at 6 a.m. Our bus transported a variety of occupants—men, women, students—young and old. We arrived at the Basilica of the National Shrine of the Immaculate Conception at 11 a.m. Members from my court, vice-regent, Annie Roney and her mother, Donna Roney, traveled with me again this year. Annie and Donna opted to spend the day at the Basilica in prayer. Many from our bus choose this option yearly, and I encourage you to consider it in the future.

Every year that I have attended the March, I have had the pleasure of meeting up with Jeanette Kitch, Regent of Court Columbia #2. Jeanette was attending her 14th March this year. Jeanette's bus leaves Meadville from St. Agatha Church at 11 p.m. on the eve of the March. They travel through the night arriving in Washington early in the morning. On Jeanette's bus this year were 18 senior high school students, 12 younger students and the remainder were adults, for a total of 42 people. The youngest traveler was a 9-month-old baby! This dedicated group did not arrive back in Meadville until well after midnight.

Catholic Daughters from around the country meet in the area of the National Gallery of Art on Constitution Avenue. CDA members are easy to find. This year, warm scarves bearing the CDA emblem and vivid CDA colors were our new calling card. We carry our Catholic Daughters for Life signs. We hoist our CDA banner. We march for the 56 million children who have been aborted since *Roe v. Wade.* We March for Life!

#### **Reminders for Financial Review**

It is almost that time of the year again—Financial Review for the period October 1, 2013 to March 31, 2014. Regents, please remember to contact your District Deputy for a date. We do ask that the DD attend both reviews if possible. The treasurer should fill out the form since she has the financial numbers, and the form could be filled out prior to the review. When the review is completed by the financial review committee members, sign the form with the DD, if she is present. The treasurer will make (4) copies with the original going to the National Office and copies to the State Regent, State Secretary, DD and a copy for your court files.

In looking over the Financial Reviews from the previous period, many courts are listing hundreds of dollars in section #3—Paid to State Court. The first line should only include the dues amount (you pay \$1.00 per member per billing period). The next line will list \$5.00, which each court is assessed. You may also add any donation you have given towards our Special State Court Projects which is Pro Life (advertising/general fund and the Haiti Community Birthing Center) and donations from our Spiritual Intention cards, which go to the North American College in Rome.

You may not list any monies from the Calendars or 10-Week Club tickets purchased by the court unless the Calendar or 10-Week Club ticket is given as a gift to a priest or a sister. The court cannot benefit from any winnings.

#### YOUTH / JCDA

The Junior Catholic Daughter program was developed in 1926 to empower girls of all ages to live their lives as disciples of Jesus Christ. To accomplish these goals, a Junior Court chooses activities to help each girl develop their Christianity and grow spiritually as they serve others through creative and flexible programs. The JCDA was established for girls from 6 to 18-years-of-age. There are two divisions: those whose ages are 6-10 are Juniorettes and those who are 11-18 are Juniors.

Every Catholic Daughter Court has the ability to sponsor a Junior Catholic Daughters of the Americas program. Guidelines for initiating a JCDA Court can be found in the Tools of the Trade or they can be obtained from National.

The Steps for initiating a JCDA Court include:

- 1. Determine the interest level in your community through talking to the priest and CDA members with daughters, granddaughters, nieces, etc.
- 2. Select a Chaplain and share the information concerning JCDA with him.
- 3. Hold an initial meeting. Advertise in the church bulletin, schools, and any other place that the information will be seen. The invitation should include the mothers. With the help of the Chaplain, information to be shared at this meeting should include the goals and program of JCDA and the good it will do for the girls, the community, for God and for the Church. Applications should be distributed at this time. A date, time and place for a second meeting (probably in one week) should be set.
- 4. The second meeting should be an organizational meeting based on the applications received. Leaders need to take the Child of God Program which is offered on the Diocesan or Parish level and have a background check, done by the State Police for a fee. The girls will be divided according to their respective age groups. The JCDA will determine the court name (it may or may not be the same as the local CDA Court), the amount of dues, and the date and time of their monthly meeting. Officers will be elected and a date for the Institution of the new JCDA Court should be set.
- 5. Installation of the new JCDA Court, Reception of New Members, and Installation of Officers will be held at the time chosen at the second meeting. The ceremonial for these can be found in the Tools of the Trade or from the National Office. The Local CDA could plan a reception following the ceremony.
- 6. Before the first official meeting of the JCDA Court, the new officers and leaders will meet to establish bylaws (guidelines in JCDA packet) and copy the Medical Release. JCDA Courts are covered by the liability insurance of the senior court.
- 7. At the first official meeting of the new JCDA Court, the bylaws need to be reviewed, changed if needed, and adopted. Medical Release forms are distributed to be returned at the next meeting. A banner will be designed by the members. Uniforms or a sash may be chosen and designed. Determine programs your court would like to

develop in order to promote God's message of service to others through community activities.

Some samples of activities a Junior Court may choose to develop are: supporting the American Cancer Society "Relay for Life," supporting the troops through various ways (Christmas or Valentine's cards, preparing "snack" boxes, etc.), supporting the elderly, or developing a youth literacy project for younger children. The interests of the Juniors should guide the project(s) you choose. There can be one "signature project" that you work all year toward or many smaller projects dealing with current needs in your community. The possibilities are endless—and as varied as the Juniors in your Court.

#### PARLIAMENTARY PROCEDURE POINTERS

# "RIGHTING" MOTION

#### (or Subsidiary Motion to Amend)

Purpose: To make the MAIN MOTION exactly the way you wanted it to be (even 5 years from now, when you look at the minutes for history—make it explicit).



The Subsidiary Motion to Amend (or "Righting Motion") clarifies the precise meaning of the motion (and amendment) on which the court will vote.

#### REMEMBER THE SUBSIDIARY MOTIONS—

all of which have RANK:

(Private to General)

Postpone Indefinitely (Private) Amendment (Corporal) Amendment the Amendment (Sergeant) Refer to a Committee (First Sergeant) (2<sup>nd</sup> Lieutenant) Postpone to a Definite Time Limit or Extend Debate (1st Lieutenant) **Previous Questions** (Captain) Lav Table (General)

If a motion is made, that is below the one pending, that motion would not be in order.

#### **EXAMPLE OF MOTIONS AND AMENDMENTS**

MAIN MOTION: "I move that the Court sponsor a Patriotic Festival at Garvey Manor on May 17, 2014"; seconded, discussion.

**AMENDMENT:** "I move to amend the motion, by adding: "featuring the making of Individual Patriotic Arrangements, and Cake Walk"; seconded; discussion.

**AMENDMENT TO THE AMENDMENT:** I move to amend the amendment by adding; "and patriotic goodies"; seconded, discussion.

If no further amendments or subsidiary motions, the vote is taken on the words (of the amendment to the amendment) only.

If it carries, these words are added to the amendment and discussion resumes on the amended amendment. If there are no further subsidiary motions or amendments, vote is taken on the amended amendment only.

If amended amendment carries, it is added to main motion, discussion continues. When there is no further discussion, vote is taken on the amended main motion.

# **MARCH FOR LIFE**

n January 22, 2014, 41 years after the Supreme Court's 1973 *Roe v. Wade* decision that legalized abortion on demand in the United States, the 40th March for Life took place on a frigid cold day in Washington, D.C. Temperatures were in the single-digits, with a wind chill of around zero. The weather canceled flights and stopped

some D.C.-bound tour buses. To the hundreds of thousands who did attend, it was a tremendous sacrifice to brave the extreme elements—but no sacrifice is too great for this cause.

Among the comments at the opening rally from Patrick Kelly, chairman of the March for Life, was that the March delivers a simple yet profound message: life is beautiful. "We may be freezing, but we're freezing for the best cause in the world." He welcomed all to the "largest and most important civil rights demonstration in the world."

The new chairman pointed out that March organizers are crafting an organization that is stronger and more effective than ever. At the rally he spoke of a new logo, new offices, a new staff and better communication with a variety of religions. The organizers are using all forms of social media at their disposal, including the use of Facebook, Twitter and Instagram to reach out to the younger generations, the generations that most need the message in their hearts. Through utilizing social media, Mr. Kelly said, "The goal is not only to come together once a year, but to be in touch with you 365 days a year and to work with you to build a culture of life in America.

The world's largest anti-abortion rally even had one very famous person's support. Pope Francis announced to his three million English language Twitter followers, "I join the March for Life in Washington with my prayers. May God help us respect all life, especially the most vulnerable."

In contrast, the White House issued a statement supporting a woman's right to an abortion and vowing to work harder to reduce the number of unintended pregnancies. President Obama expressed support for the Supreme Court decision that gave America an unfettered right to abortion, calling it a "historic commitment to protect the health and reproductive freedom of women." This statement should not come as a surprise as the president has said earlier that he wanted that choice (abortion) available in case one of his daughters needed access to it.

The overriding theme of this year's March was **adoption**. According to March for Life President Jeanne Monahan, there are 64 abortions for every child who is adopted in the U.S. She said, "We want to encourage women facing the option of abortion to choose adoption. Adoption is at the center of motherhood. Motherhood is all about sacrifices. This is an ultimate sacrifice for the good of the baby."

Thousands of youth gathered in Washington. Prior to the March, it was reported that more than 10,000 attended the Youth Rally and Mass for Life at the Verizon Center in downtown Washington. An additional Youth Rally and Mass for Life with thousands in attendance was held in the Stadium Armory. With their energetic presence, the large number of young people made a profound impact on all marchers. It is reported that 80 percent of the marchers were 25 years of age or younger. The conviction of the youth are our bright future in this fight. They are not afraid to stand up for their unborn brothers and sisters. They ARE the generation for Life!
